

Promotion Terms and Conditions “ZND LAUNCHPOOL – SURPRISE”

§ 1 General provisions

1. These terms and conditions (hereinafter: “**Terms and Conditions**”) set out the rules of participation, including the conditions that must be met in order to participate in the “*ZND Launchpool – Surprise*” promotion (hereinafter: “**Promotion**”).
2. The organizer of the Promotion is: BB Trade Estonia OÜ with its registered office in Harju maakond, Tallinn, Lasnamäe linnaosa, Tähesaju tee 9, 13917 Estonia (office number 10), entered in the Register of Entrepreneurs under number 14814864, which is the operator of the zondacrypto exchange with the support of ZND. CO OÜ with its registered office in Tallinn at: Harju maakond, Tallinn, Lasnamäe linnaosa, Tähesaju tee 9 (office number 7), 13917, Estonia (hereinafter: “**Organizer**”).
3. The Promotion Organizer's tasks include ongoing supervision of the Promotion, in particular determining whether there is a risk of violating the Promotion rules set out in these Terms and Conditions.
4. The Organizer also uses definitions in these Promotion Terms and Conditions that are consistent with the definitions included in the terms and conditions available at <https://zondacrypto.com/pl/legal/zonda-exchange> and <https://znd.co/>, to which reference is made in this regard. In case of any conflict between the provisions of the above-mentioned rules and these Terms and Conditions, the provisions of these Terms and Conditions shall apply.
5. For the purposes of these Terms and Conditions, the terms listed below shall have the following meanings:
 - a. **Customer** - a User who, through full verification of their Account on the Partner's Platform, intends to take advantage of the Promotion and comes from a country/region served by the Exchange, which must be clearly evident from the documents submitted during the verification process (KYC);
 - b. **Digital Asset/Digital Assets** - a digital representation of a given value or right, processed and stored in a virtual database, the integrity and correctness of which is secured by cryptographic methods. Digital Assets include, among others: cryptocurrencies, tokens, NFTs, contracts;
 - c. **ZND Token** - a utility token created by the Organizer. Details regarding functionality, issuance, and other relevant information can be found in the “*ZND Token White Paper*” available at: <https://assets.znd.co/token/pl/whitepaper>.
 - d. **Account** - part of the Organizer's Platform available to the User or Customer after logging in, protected by a password and secured by two-step authentication, constituting a resource of the User's or Customer's data and information about their activities on the Partner's Platform;
 - e. **Organizer** (or **Organizers**) - BB Trade Estonia OÜ with its registered office in Harju maakond, Tallinn, Lasnamäe linnaosa, Tähesaju tee 9, 13917 ESTONIA, registered in the commercial register under number: 14814864, VAT number: EE102200164;
 - f. **Administrator** (or **Personal Data Administrator**) - Organizer;

- g. **Organizer's Platform** - an online platform available at the public internet address <https://zondacrypto.com> (hereinafter also referred to as: “**zondacrypto Platform**”) and <https://znd.co> (hereinafter also referred to as: “**ZND Platform**”), as well as in the Mobile Application;
- h. **Mobile Application** - Partner's mobile application, available for download on mobile devices with the following operating systems:
 - i. Android - application named “zondacrypto2.0: trade tomorrow” available in the Google Store at <https://play.google.com/store/apps/details?id=com.zondacrypto.exchange&hl=pl&pli=1>,
 - ii. iOS - mobile application named ‘zondacrypto: trade tomorrow’ (available in the App Store at <https://apps.apple.com/pl/app/zondacrypto-trade-tomorrow/id6482290108?l=pl>).

The Mobile Application installed on the Customer's mobile devices allows them to use the Partner's Platform within the iOS (iPhone) and Android operating systems;

- i. **Promotion** – a promotional campaign conducted by the Organizer on the rules described in these Terms and Conditions;
 - j. **Terms and Conditions** – this document specifying the rules and technical conditions of the “*ZND Launchpool – Surprise*” Promotion;
 - k. **Organizer's Terms and Conditions** - terms and conditions for the provision of electronic services by the Organizer, posted on the Organizer's Platform, available at <https://zondacrypto.com/pl/legal/zondacrypto-exchange>, as well as <https://znd.co/pl/>, in particular the Terms and Conditions for the Provision of zondacrypto Services: <https://zondacrypto.com/pl/legal/zondacrypto-exchange/regulamin-swiadczenia-u-slug> and the ZND Platform Terms and Conditions (<https://assets.znd.co/agreements/pl/platform-terms-and-conditions.pdf>);
 - l. **Registration** - creation of an Account on the Organizer's Platform by the Participant.
 - m. **Verification** - a set of activities constituting the verification of the Account after Registration, consisting in particular of the correct completion of the electronic form available on the Partner's Platform, in accordance with the rules set out in the Partner's Terms and Conditions (in particular in the Terms and Conditions of Service Provision zondacrypto);
 - n. **Exchange** - zondacrypto cryptocurrency exchange - <https://zondacrypto.com/pl/home>.
6. The Promotion may be shared by the Organizer via the following social media on the Organizer's profiles/channels listed below (hereafter referred to as: “**Social Media**”):

7. The Promotion is aimed at individuals who:
 - have registered and verified (or plan to, subject to § 2 point 4 of the Terms and Conditions) their customer/user accounts on the Organizer's platforms <https://www.zondacrypto.com> (hereinafter: **“zondacrypto Platform”**) and <https://znd.co> (hereinafter: **“ZND Platform”**); (hereinafter collectively: **“Platforms”**), or
 - already had registered and verified customer/user accounts on the Platforms before the start of the Promotion.
 8. The Organizer emphasizes that the Promotion is not co-created, administered, or sponsored by Social Media.
 9. The Promotion Organizer is the sole sponsor of the Promotional Prizes.
 10. The Promotion does not constitute a cash lottery, raffle, promotional lottery, or any other game of chance or mutual betting within the meaning of Article 2 of the Act of November 19, 2009, on gambling (Journal of Laws No. 201, item 1540, as amended).

§ 2

Participation in the Promotion

1. The Promotion is intended for individuals who are of legal age (18 years or older), have or plan to have a registered and verified customer/user account on both Platforms, subject to § 1 (7) of the Terms and Conditions.
2. A participant in the Promotion is a person who has met all the requirements specified in these Terms and Conditions and has active, verified, and linked accounts on the Platforms, subject to § 1 (7) of the Terms and Conditions.
3. By registering and verifying customer/user accounts on the Platforms, as specified in § 2 sections 1 and 2 above, it is understood that the Participant has accounts on the Platforms and has successfully completed the authentication process (KYC) by correctly passing all its stages. The Organizer allows Participants to create customer/user accounts on the Platforms and complete the KYC process during the Promotion, but no later than at the time of its completion in accordance with § 3(1) of the Terms and Conditions. The Organizer will verify compliance with the above criterion by checking whether the Participant has active and verified customer/user accounts on the Platforms at the above-mentioned time. If the above requirement is not met, the Organizer reserves the right to refuse to award the Prize to a given Participant. The Organizer also reserves the right to determine that fulfillment of this requirement after the start of the Promotion may deprive the Participant of the opportunity to complete certain Promotional Tasks that are related to taking actions on the Platforms.
4. Participation in the Promotion is strictly personal, therefore it is not permitted to register for the Promotion on behalf of third parties. The identity and other information about the Participant should be consistent with the data (including personal data) provided in the Promotion and during the registration and identity verification process on the Platforms. The Organizer reserves the right to verify, including verification of the identity of

Promotion Participants, and in the event of reasonable doubts as to the fulfillment of the above conditions, to refuse to award the Participant a Prize in the Promotion on this basis.

5. The Promotion is not available to employees, members of the management and representatives of the Organizer and other entities directly involved in the preparation and conduct of the Promotion, as well as persons permanently cooperating with the above-mentioned entities on a basis other than an employment relationship, and members of their immediate families, i.e., ascendants, descendants, siblings, spouses, parents of spouses, and persons related to them by adoption.
6. The condition for participation in the Promotion is acceptance of these Terms and Conditions and expression of willingness to participate in the Promotion by submitting a promotional application through the completion of promotional tasks and meeting the requirements of the Terms and Conditions.
7. Participants joining the Promotion in accordance with the preceding paragraphs are required to read the provisions of the Terms and Conditions. By participating in the Promotion, you accept the provisions of these Terms and Conditions.
8. Participation in the Promotion is entirely voluntary and free of charge.
9. Participation in the Promotion and the related provision of personal data is entirely voluntary, based on the Participant's consent, in accordance with § 9(2)(a) of these Terms and Conditions.

§ 3

Duration of the Promotion

1. The promotion runs from October 15, 2025, at 0:00 UTC to October 24, 2025, at 23:59 UTC (hereinafter: **"Promotion Period"**).
2. The results of the Promotion will be determined and the winners announced within 14 days of the end of the Promotion.
3. Prizes will be awarded to the winners within 6 months of the end of the Promotion.

§ 4

Promotion Rules

1. To participate in the Promotion, the Participant must complete promotional tasks consisting of the Participant performing the following activities (hereinafter referred to as: **"Promotional Task"**):
 - a. activation of the ZND Earn service on the ZND Platform on a dedicated Promotion Subscription Plan on the ZND token - ZND Earn APR 0% (hereinafter: **"ZND Earn"**);

- b. earning as many ranking points as possible (hereinafter: **“Ranking Points”**) by completing the task specified in § 4(1)(a) above, in accordance with the criteria for earning Ranking Points specified in § 4(5) of the Terms and Conditions, hereinafter: **“Promotional Application”**.
- 2. The ZND Earn service can only be activated during the Promotion Period for a period of 15 days, 30 days, or 45 days, with the proviso that each of the selected Subscription Plans is subject to an Annual Percentage Rate (APR) of 0 (0% Annual Interest Rate).
After the end of the Promotion, the dedicated ZND Earn 0% service will be disabled and it will not be possible to take advantage of the Promotion.
- 3. Participants earn Ranking Points by completing Promotional Tasks, on the basis of which Prizes will be awarded after the end of the Promotion.
- 4. The Ranking Points earned by Participants will be calculated after the Promotion ends.
- 5. The number of Ranking Points earned is not constant and is subject to various multipliers. Their value depends on the following factors:
 - a. Number of frozen ZND tokens - the greater the number of frozen ZND tokens, the more Ranking Points the Participant earns. By default, Participants earn 1 Ranking Point for each 1 frozen ZND token using the ZND Earn service.
 - b. Length of the freeze period - the length of the ZND Earn subscription affects the value of the Ranking Points earned according to the following multiplier (the Ranking Points earned will be multiplied by the indicated values):
 - i. ZND Earn for 15 days - multiplier 1.0 (default);
 - ii. ZND Earn for 30 days - multiplier 1.5;
 - iii. ZND Earn for 45 days - multiplier 2.0;
 - c. The period during which the ZND Earn service was activated - depending on when the ZND Earn subscription was activated, Ranking Points may be multiplied according to the following periods:
 - i. Period I: from October 15, 2025, to October 21, 2025 - Ranking Points are subject to a multiplier of 1.5;
 - ii. Period II: from October 22, 2025 to October 24, 2025 - Ranking Points are subject to a multiplier of 1.0 (default).
 - d. Participant Loyalty Tier - depending on the Participant's Loyalty Tier in the ZND Loyalty Program, Ranking Points will be multiplied as follows:
 - i. Basic Tier - multiplier 1.0 (default);
 - ii. Silver Tier - multiplier 1.2;
 - iii. Gold Tier - multiplier 1.4;
 - iv. Platinum Tier - multiplier 1.6;
 - v. Diamond Tier - multiplier 1.8;
 - vi. Ambassador Tier - multiplier 2.0.
- 6. The Promotion is a “surprise launchpool,” which means that rewards will be distributed proportionally to the amount of frozen ZND tokens.

7. The total prize pool will be divided proportionally among all Participants who have earned Ranking Points.
8. Participants are required to maintain an active subscription to the selected ZND Earn Subscription Plan for the entire declared period of such service. If the selected subscription is terminated before the declared period, such activity will not be taken into account for the Ranking Points earned.

10. Detailed rules of the Loyalty Program referred to in § 4(5)(d) above are available in the Loyalty Program Terms and Conditions, available on the ZND Platform at: <https://assets.znd.co/agreements/pl/loyalty-program-agreement.pdf>, to which the Organizer hereby refers.
11. Participants are required to perform the Promotional Tasks honestly and in accordance with the provisions of the Regulations. In the event of reasonable doubts in this regard, the Organizer reserves the right to exclude such a Participant.
12. The Promotion is open, i.e., anyone who meets the requirements specified in the Terms and Conditions may participate.
13. If the Participant completes only some of the Promotional Tasks or completes any of the Promotional Tasks after the Promotion Period has expired, such Promotional Entry will not be considered by the Organizer.
14. Promotional Entries will be evaluated by a promotional committee (hereinafter referred to as: “**the Committee**”), which will consist of representatives of the Organizer and persons appointed by the Organizer, as specified in § 7 of the Rules.
15. After the Promotion ends, all Participants who have completed the Promotional Tasks specified in § 4(1) of the Rules will receive a proportional prize specified in § 5 of the Rules (hereinafter referred to as: “**Winner**” or “**Winners**”).
16. When determining the Winners, the Committee shall also decide on the award of a given prize in the Promotion to a given Winner, guided by the criteria described in the Rules and verifying that the Winner meets the conditions set out in the Rules. Failure to meet these conditions may result in the exclusion of such a Participant from the Promotion and the awarding of the Prize to another Participant, as well as the forfeiture of the Prize in favor of the Organizer (in the absence of Participants meeting the conditions for the award of the Prize).
17. After the Promotion ends, the Organizer will announce how many Participants took part in the Promotion and provide information about the number of ZND Earn subscriptions activated as part of the Promotion.

18. The Organizer reserves the right to exclude from participation in the Promotion or deprive of the right to the Prize Participants whose actions are contrary to the law, good manners, or the Terms and Conditions, in particular Participants who:
- do not act personally, but through third parties;
 - use different accounts on the Organizer's Platform to act on behalf of/register the same Participant;
 - if third-party claims have been made in relation to their Promotional Submission,
 - come from a country/region not served by the zondacrypto cryptocurrency exchange (in accordance with § 2(1) of the Terms and Conditions).
19. In order to clarify any doubts related to the Participant's activity in the Promotion, the Organizer may contact the Participant using the means of communication provided by them; during such contact, the Organizer may expect the Participant to provide detailed information regarding their participation in the Promotion.

§ 5 Prizes

1. The following surprise prizes (hereinafter referred to as: **“Prize”**) will be awarded as part of the Promotion:
 - a. participation in a new technological initiative carried out as part of the ZND project. The total estimated prize pool for the Promotion will be equivalent to approximately PLN 150,000.00.
2. Detailed information about the Prizes, including their exact form, will be announced after the end of the Promotion Period. The Organizer also reserves the right to announce the Prizes before the end of the Promotion, but not earlier than October 22, 2025.
3. The prizes will be awarded to the Winners within 6 months of the end of the Promotion. Detailed rules for awarding the Prizes will be announced after the end of the Promotion.
4. Prizes will only be awarded to Participants who have used the ZND Earn service for the entire declared period. If a Participant has terminated their ZND Earn Subscription before the declared period, such activity will not be taken into account.
5. The Organizer reserves the right to change the number of Prizes in favor of the Winners (by awarding additional prizes).
6. Each Promotion Winner is entitled to only one Prize.
7. The right to the Prize cannot be transferred to third parties.
8. Prizes cannot be exchanged for cash equivalents or other services covered by the Organizer's offer.
9. It is possible to decline the Prize. If the Winner declines the Prize, the Organizer reserves the right to award the Prize to another Participant designated by the Commission.

§ 6

Organizer's Liability

1. The Organizer shall not be liable for the inability to deliver the Prize to the Winner and fulfill the Prize for reasons beyond the Organizer's control, including events of force majeure. In such a case, the Winner will be informed of the above circumstances in a private message or will be asked to contact the Organizer by e-mail.
2. The Organizer shall not be liable for random events preventing Participants from participating in the Promotion.
3. The Organizer shall not be liable for the Participants' inability to achieve the expected results of transactions on the Platforms for reasons attributable to the Participants.
4. The Organizer does not provide any advice, recommendations, analyses, or suggestions regarding investing on the Platforms. The Organizer is not a broker, intermediary, agent, or advisor to the Participant and has no fiduciary relationship or obligations to the Participant in connection with the Participant's participation in the Promotion or other activities performed by the Participant on the Platforms in this regard. The Organizer does not recommend buying, selling, or holding any cryptocurrencies and informs that investing in cryptocurrencies involves a high degree of risk. There is a risk of losing the invested funds due to changes in cryptocurrency exchange rates.
5. Any marketing material related to the Promotion concerning the crypto asset has not been reviewed or approved by any competent authority in any Member State of the European Union. The sole responsibility for the content of the marketing material concerning the crypto asset lies with the crypto asset provider. The crypto asset in the form of the ZND Token is offered by BB Trade Estonia OÜ, based in Tallinn (Estonia), the operator of the zondacrypto exchange available at <https://zondacrypto.com/pl/home>. The crypto asset provider can be contacted by phone at +48 884 570 061 or by email at support@zondacrypto.com. The information document in the form of a white paper concerning the ZND Token has been published at <http://assets.znd.co/token/pl/whitepaper>.

§ 7

The Commission

1. A committee appointed by the Organizer, consisting of two persons selected by the Organizer, will supervise the proper conduct of the Promotion.
2. The tasks of the Commission referred to in the preceding paragraph include, in particular:
 - verifying that a given Participant meets all the conditions for participation in the Promotion;
 - selecting the Winners of the Promotion;
 - considering Participant complaints in accordance with § 8 of the Rules.

§ 8

Complaints

1. Complaints related to participation in the Promotion may be submitted by the Participant:
 - a. by mail, to the address of the zondacrypto headquarters (Tähesaju tee 9, Tallinn, 13917, Estonia); or

 - c. by filling out the form: <https://zondacrypto.com/en/helpdesk/contact-page>.
2. Complaints should be submitted immediately after the occurrence of an event raising objections by a Participant taking part in the Promotion, but no later than 14 days after the end of the Promotion (for complaints sent by registered mail, the date of the postmark is decisive).
3. The complaint should contain all the information specified in the regulations available on the zondacrypto platform at <https://zondacrypto.com/pl/legal/zonda-exchange>, including § 18 of the Terms and Conditions of Service, in connection with the Complaint Submission Procedure on the zondacrypto platform, available at: <https://zondacrypto.com/documents/d/guest/procedura-skladania-skarg-pl-docx>.
4. Complaints are handled in accordance with the procedure set out in the regulations referred to in section 3 of this paragraph, including the Terms of Service - § 18. Detailed rules for the complaint procedure can be found in a separate document referred to in the Terms of Service - Procedure for Submitting Complaints on the zondacrypto Platform, available at: <https://zondacrypto.com/documents/d/guest/procedura-skladania-skarg-pl-docx>.
5. Complaints will be considered by the Organizer.

§ 9

Personal data

1. The administrator of personal data is BB Trade Estonia OÜ, with its registered office at Harju maakond, Tallinn, Lasnamäe linnaosa, Tähesaju tee 9, 1391 Estonia (office number 10), a company incorporated under Estonian law, registered in the register of entrepreneurs under number: 14814864 (hereinafter: **“Data Administrator”**).
2. The Administrator processes the personal data of Promotion Participants and Winners on the basis of:
 - a. consent within the meaning of Article 6(1)(a) of Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016, on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter: **“GDPR”**);
 - b. fulfilling the legal obligation incumbent on the Data Controller within the meaning of Article 6(1)(c) of the GDPR in order to comply with the obligation to store accounting documents;
 - c. the legitimate interest of the Data Controller in accordance with Article 6(1)(f) of the GDPR, consisting in particular in responding to any complaints or claims made as a result of this Promotion.
3. All data obtained by the Organizer about Participants and Winners of the Promotion will be deleted or anonymized within 60 days from the date of the end of the Promotion or sending the Prize to the Winners of the Promotion.
4. The data of Participants and Winners of the Promotion will be deleted or anonymized in accordance with the preceding paragraph, with the exception of data that will be necessary to fulfill the legal obligations incumbent on the Data Controller and to pursue the legitimate interests of the Data Controller - necessary to consider complaints or other forms of claims submitted by Participants or Winners of the Promotion or other persons, as well as for the purposes of possible court or administrative proceedings.
5. The data is protected by technical and organizational measures to ensure an adequate level of protection in accordance with applicable regulations.
6. The Data Administrator processes only personal data provided as part of the Promotion. Personal data is not subject to automated decision-making for the purposes of the Promotion.
7. For the purposes of the Promotion, personal data will be made available to companies affiliated with the Data Controller in terms of capital and personnel, i.e. Orion Software sp. z o. o. and Expofer Servis House s. r. o., as well as the operator of the ZND.co platform (ZND.CO OÜ).
8. Participants in the Promotion have the right to:

- a. request the Data Administrator to access personal data concerning the data subject, rectify, delete or restrict processing, and the right to object to processing, as well as the right to transfer data;
 - b. file a complaint with the supervisory authority—the Estonian Data Protection Inspectorate, 39 Tatari, 10134 Tallinn, Estonia—if the Participant believes that their personal data is being processed unlawfully.
9. All requests, questions, and demands related to data processing should be directed to the Data Protection Officer appointed by the Data Administrator: gdpr@zondacrypto.com.

§ 10

Final provisions

1. These Terms and Conditions are the only document specifying the detailed rules of the Promotion.
2. The Terms and Conditions are available throughout the Duration of the Promotion on the Organizer's website and at the Organizer's headquarters.
3. The Organizer is entitled to modify the content of the Terms and Conditions, either in part or in whole, at any time for reasons beyond the Organizer's control, as well as when such a change is made solely for the benefit of the Participants. Participants will be notified of any planned changes to the Terms and Conditions at least 7 days prior to the changes being implemented by posting information on the Organizer's Platform.
4. If the Participant does not accept the changes to the Terms and Conditions, the Promotion for such Participant will be terminated. Failure by the Participant to indicate their non-acceptance of the changes to the Terms and Conditions before the date of their entry into force, subject to the deadline referred to in point 1 above, shall be deemed acceptance of the new Terms and Conditions.
5. Customers participating in the Promotion are required to comply with the provisions of these Terms and Conditions.
6. In matters not covered by these Terms and Conditions, the provisions of the Organizer's Terms and Conditions and generally applicable laws shall apply. In the event of any conflict between the provisions of these Terms and Conditions and the provisions of the Organizer's Terms and Conditions, the provisions of these Terms and Conditions shall apply.

8. These Rules and Regulations shall be effective as of October 15, 2025.
